



- 1. CONCRETE FLOOR ASSEMBLY (2-HR. FIRE-RATING) :
 - A. LIGHTWEIGHT OR NORMAL WEIGHT CONCRETE FLOOR (MINIMUM 4-1/2" THICK).
 - B. PRECAST (HOLLOW-CORE) CONCRETE FLOOR (MINIMUM 6" THICK).
- 2. MAXIMUM 4" NOMINAL DIAMETER STEEL PIPE (SCHEDULE 10 OR HEAVIER) OR CAST/DUCTILE IRON PIPE TO TERMINATE 1-1/2" TO 12" BELOW BOTTOM SURFACE OF FLOOR AND A MINIMUM 1-3/4" ABOVE TOP SURFACE OF FLOOR.
- 3. NONMETALLIC PIPE TO BE ANY OF THE FOLLOWING:
 - A. MAXIMUM 4" NOMINAL DIAMETER PVC PLASTIC PIPE (CELLULAR OR SOLID CORE).
 - B. MAXIMUM 4" NOMINAL DIAMETER CPVC PLASTIC PIPE (CLOSED PIPING SYSTEM ONLY).
 - C. MAXIMUM 4" NOMINAL DIAMETER ABS PLASTIC PIPE (CELLULAR OR SOLID CORE).
- 4. COMPRESSION TYPE COUPLING WITH ELASTOMERIC GASKET AND A STAINLESS STEEL JACKET WITH STAINLESS STEEL BAND CLAMPS USED TO SECURE METALLIC PIPE WITH NON-METALLIC PIPES.
- 5. HILTI CP 648E WRAP STRIP (NOMINAL 3/16" THICK x 1-3/4" WIDE) CONTINUOUSLY WRAPPED AROUND THE OUTER CIRCUMFERENCE OF THE NON-METALLIC PIPE BELOW FLOOR, COVERING TWO TIMES, WITH ENDS BUTTED AND HELD IN PLACE WITH TAPE. WRAP STRIP TO BE BUTTED UP AGAINST THE COMPRESSION COUPLING.
- 6. HILTI 1-3/4" RETAINING COLLAR WRAPPED OVER THE WRAP STRIPS, OVERLAPPING MINIMUM 1".
 ANCHOR TABS SHOULD REMAIN UNBENT.
- 7. NOMINAL 1/2" WIDE STAINLESS STEEL HOSE CLAMP(S) FASTENED AT MID-HEIGHT OF RETAINING COLLAR AND DIRECTLY ABOVE COMPRESSION COUPLING.
- 8. HANGER STRAPS (28 GA. STEEL) TO BE MINIMUM 1/2" WIDE TAPERING TO 1/4", EXTENDING MINIMUM 1" ONTO METAL PIPE ABOVE COMPRESSION COUPLING. HANGER STRAPS CAN BE MADE FROM ADDITIONAL ANCHOR TABS OF RETAINING COLLAR (SEE NOTE NO. 3 BELOW).
- 9. MINIMUM 4" THICKNESS MINERAL WOOL (MIN. 4 PCF DENSITY) TIGHTLY PACKED (SEE NOTE NO. 4 BELOW).
- 10. MINIMUM 1/2" DEPTH HILTI FS-ONE MAX INTUMESCENT FIRESTOP SEALANT.
- 11. MINIMUM 1/2" BEAD HILTI FS-ONE MAX INTUMESCENT FIRESTOP SEALANT APPLIED AT POINT OF CONTACT.

NOTES: 1. MAXIMUM DIAMETER OF OPENING = 6-1/4".

- 2. ANNULAR SPACE = MINIMUM 0", MAXIMUM 1-1/2".
- 3. HANGER STRAPS TO BE SECURED TO COLLAR ASSEMBLY INSERTING 1/4" END INTO OPENING IN RETAINING COLLAR ANCHOR TAB AND BENDING 180°. THE 1-1/2" END SHALL ALSO BE BENT 180° AND SLID OVER THE COLLAR CLAMP PRIOR TO TIGHTENING COLLAR CLAMP(S). TWO HANGERS ARE REQUIRED FOR NOMINAL 2" PIPES AND SMALLER. THREE HANGERS ARE REQUIRED FOR PIPES NOMINAL 2-1/2" TO 4".
- 4. WHEN HOLLOW-CORE FLOORS ARE USED, MINERAL WOOL MUST BE INSTALLED FLUSH WITH BOTTOM SURFACE OF FLOOR.
- 5. CLOSED OR VENTED PIPING SYSTEMS (PVC, ABS = SCHEDULE 40; CPVC = SDR 13.5).
